



A RESOLUTION RECOMMENDING LONG ISLAND BUILDERS & CONSTRUCTION, THE SINGLE CALCULATED & RESPONSIVE BIDDER (SCRB) FOR THE CONSTRUCTION OF SWIMMING POOL FOR JRMSU-TAMPILISAN CAMPUS (P.R. NO. 22-03-197) FOR APPROVAL

WHEREAS, the Jose Rizal Memorial State University (JRMSU)- Tampilisan Campus has an Approved Budget for the Contract of Two Million Pesos Only (₱2,000,000.00) for the Construction of Swimming Pool as provided in the approved FY 2022 Budget for the Special Trust Fund Subsidy (STF) and the 2022 Annual Procurement Plan;

WHEREAS, JRMSU BOR Resolution Number 062-2022, the JRMSU Board of Regents approved to commence the procurement process for the Construction of Swimming Pool for JRMSU-Tampilisan Campus for Fiscal Year 2022;

WHEREAS, pursuant to Republic Act 9184, the Bids and Awards Committee (BAC) of the JRMSU-Tampilisan Campus conducted the Pre-Procurement Conference for the Construction of Swimming Pool on June 23, 2022 @ 9:00 o'clock in the morning;

WHEREAS, the Jose Rizal Memorial State University-Tampilisan Campus advertised the invitation to Bid for the Construction of Swimming Pool (**P.R. NO. 22-03-197**) with an Approved Budget for the Contract (ABC) of **Two Million Pesos Only (₱2,000,000.00)** in the Government Procurement System (PhilGEPS) and in the conspicuous place at the premises of the JRMSU-TC and conducted the Pre-Bid Conference on July 6, 2022 @ 9:00 o'clock in the morning;

WHEREAS, in response to the said advertisements, only one (1) interested bidder, **LONG ISLAND BUILDERS AND CONSTRUCTION** purchased the bidding documents and submitted proposal on the scheduled Bid Opening on June 18, 2022 at 2:00 o'clock in the afternoon;

WHEREAS, after thorough technical and financial evaluation, **LONG ISLAND BUILDERS AND CONSTRUCTION** was found to be qualified and eligible with the following bid proposal;



- b. Recommend for the approval by the Campus Administrator of Jose Rizal Memorial State University-Tampilisan Campus to award **LONG ISLAND BUILDERS AND CONSTRUCTION** for the Construction of Swimming Pool in the amount of **One Million Nine Hundred Ninety-Nine Thousand Seven Hundred Seventy-Five Pesos & 25/100 Only (P1,999,757.25)**.
