Invitation to Bid for the Construction of 1 Unit, 2 Storey, 12 Classroom Building & Facilities: P20, 996,000.00

1. The *Construction of 1 Unit, 2 Storey, 12 classroom School Building & Facilities*, through the General Appropriations Act 2018¹ intends to apply the sum of Twenty Million Nine Hundred Ninety Six Thousand Pesos (₱ 20,996,000.00) only being the Approved Budget for the Contract (ABC) to payments under the contract for *Construction of 1 Unit, 2 Storey, 12 classroom School Building & Facilities / PR# 18-01-087*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *Construction of 1 Unit, 2 Storey, 12 classroom School Building & Facilities* through the General Appropriations Act 2018² intends to apply the sum of Twenty Million Nine Hundred Ninety Six Thousand Pesos (₱ 20,996,000.00) only being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
3. The JOSE RIZAL MEMORIAL STATE UNIVERSITY – Tampilisan Campus now invites bids for the *Construction of 1 Unit, 2 Storey, 12 classroom School Building & Facilities*. Completion of the Works is required within Two Hundred Thirty (230) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in **Error! Reference source not found.**
4. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

A complete set of Bidding Documents may be acquired by interested bidders on *March 16, 2018* at the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Thousand Nine Hundred Ninety Six Pesos (₱ 20,996.00) only.*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Jose Rizal Memorial State University – Tampilisan Campus will hold a Pre-Bid Conference³ on March 23, 2018, 8 o'clock in the morning at the BAC Office, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before April 4, 2018 @ 8 o'clock in the morning. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on April 4, 2018 @ 8 o'clock in the morning at *the BAC Office of JRMSU – Tampilisan Campus*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
